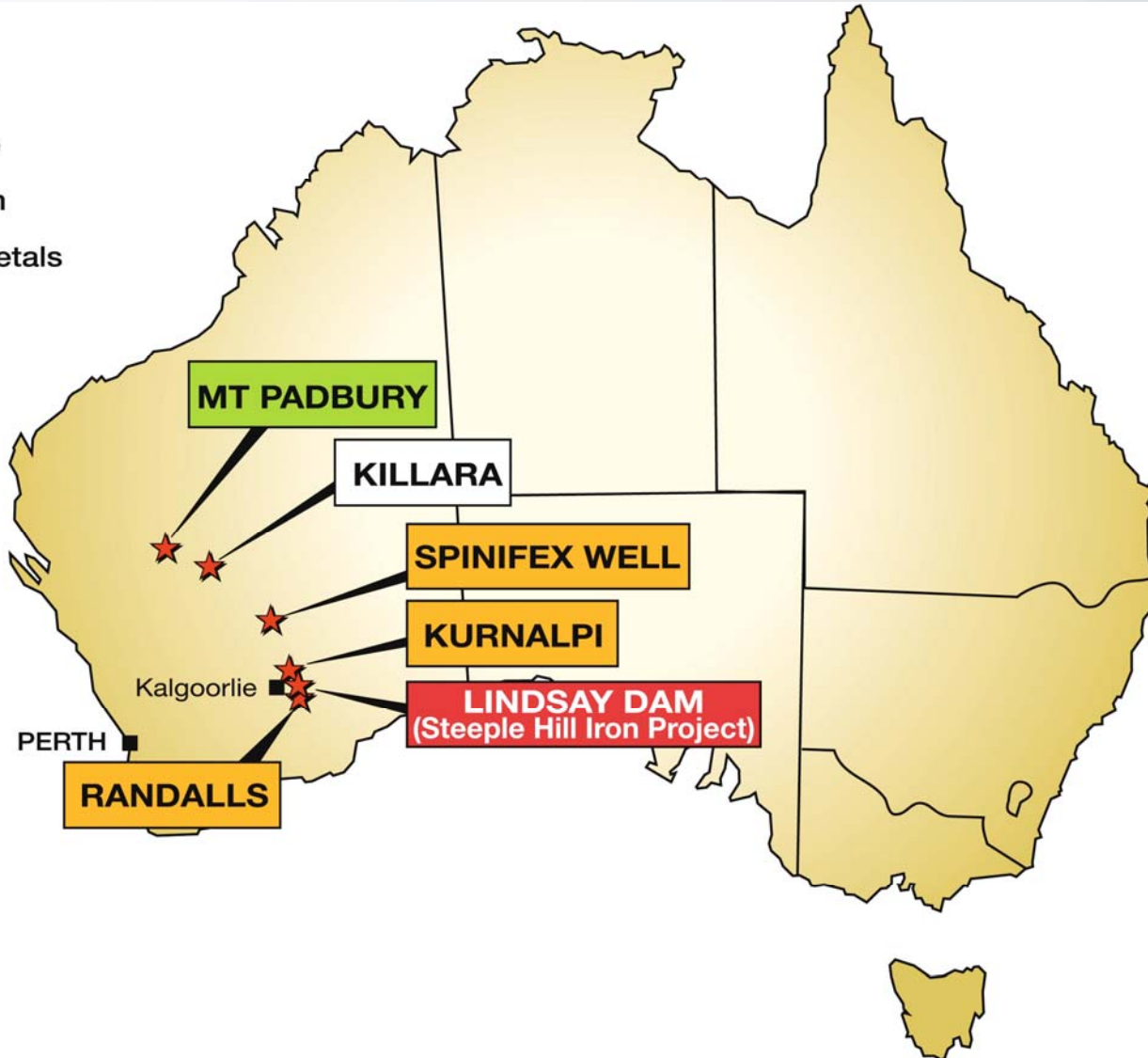

# SHIP Resource

- The Resource at the Steeple Hill Project could be increased to **131 Mt** of Alluvial Ore containing **19 Mt @ 58 % (Fe)** Iron with 7% SiO<sub>2</sub>, 6% Al<sub>2</sub>O<sub>3</sub> and 0.01% P; using a lower hematite recovery cut-off of 5% (Previously 10%). (AMC)
- Testwork by metallurgists indicate ultrafine hematite could add an extra 4% Hematite recovery; giving an extra **5 Mt** Hematite.
- Further drilling on 200 x 200 m grid will serve to further increase the Resource available to FairStar.
